The Meeting was called to order at 7;12 p.m. by President Little.

Committee Reports: Friends of the Library are very busy. Book Sales are running about \$400.each. Friends have received many nice things from Joan Spencer to raffle off, beside the baskets.

Friends give to the Library normally \$5,000. But last year and this year will be much more, this year will be about 10,000. This money is to be use to help pay of the Library Mortgage. The Friends were thanked for their help and support.

Maintenance: Leo has not been able to get to the front door but it is on his list.

Lights- Leo will take care of them this week.

Budget Lindsay and Huck have finished the budget. Motion to move excess will be done under new business.

Communications: Were unable to get weed and feed grant as it was not received on time. Huck was given the forms by Director and found an error, so she mailed it Priorty mail on June 13<sup>th</sup> to make sure it would get there in time ,but it was not received in Springfield until June 20<sup>th</sup>. Letter received denying our request but they did say they had received 800 applicants,so we might not have gotten it anyway.

Old Business: If no election, then we won't be able to get on the ballot for expansion/annexation.

Secretary found application for Library Per capita & aid grants in her box. Director had been taking care of it, but since it isn't due until October ,was suggested to wait and give it to new director.

Theft of Library property: Lindsay reported nothing new other than money put in budget for the scanners and check –out system.



Cash Register; Little didn't get to check yet . Will put on hold for now.



Change of names on Credit cards; Secretary to write a letter requesting that Valerie Meyer's name be taken off and Huck & Little's names be put on. Treasurer will deliver letters to Office Max, Office Depot, Borders.

Receipt Printers: Check with Bill Stephens to see if we've gotten them yet.

Coin Copier; October was decided as the month to get bids for the copier as the contract will end on the coin copier in February, 2006.

Research cost of server softwear: Checked with Bill Stevens and he will get it for us, will be able to connect to all computers. He also stated that the board can have access to the computers.

Comment Box: Have to get one with two locks, one for director and one for president. President Little said he had checked with Mr. Eastman and the board does have access to the comment box.

Audit of Secretary's Book: Lindsay said they had everything but June and Stolzer said she had found some other things missing. They will check on everything after the meeting.

Postage Meter: Huck Checked with Pitney –Bowes. If we want to send it back we can. The post office will charge to the credit card. Pat will talk to the Postal Director. Best bet will be to get an account at the post office.

Fire Inspection: Clean up back, Huck to see to it. Weber checks the fire extinguishers in July each year. Check with our insurance agent Mr. Dave Margario.

Staffing: Check with Denise on whether we will be covered. Doug will talk with Denise. Will have Denise and Doug do the time sheets for Dave Roady. Ashcraft suggested we check into seeing about Hospital Insurance for the staff. Check with Bill Stevens to see about what may be available through Library Associations.
