Approval of Minutes-

<u>Treasurer's Report</u>- We are on target, on budget, and receiving large quantities of tax money. We received a \$785 donation in memoriam of Tami Adelhardt, a Friends of the Library member who passed away.

Director's Report-

- The Per Capita grant is completed and only needs the official census added to it before submission.
- The Polar Express program is completely filled with 132 people signed up to attend.
- Our book checkouts are up & computer usage is consistent.

- a) We received a \$1,850 invoice from Kone Elevator for maintenance regarding the door & cleaning.

Old Business-

- a) Green Space- There is nothing major, just winterization and chair covers.
- b) Internet Bids- We received updated information regarding the internet contract we selected from ICN at the last meeting. There were additional fees and expenses regarding "permits and contingencies" disclosed after the board meeting as well as no contracts. It would simply be a month-to-month bill.
 - AT&T has contract breakage fees and can't guarantee rates after the contract. The
 installation is between \$4,760 and \$5,120 based on package selection. Increases are
 capable as needed. For 20 Mb
 - o 36 month contract the bill would be \$315 with a \$5,120 installation fee.
 - o 60 month contract the bill would be \$284 with a \$4,760 installation fee.
 - The Friends of the Library have offered to pay the installation fee upfront to avoid additional monthly charges.
 - Whisper is \$94.99 with 20 Mb download and 4 Mb upload. With setup fees ranging from free to \$300 based on package selection. It is all WiFi based.
