OCLC Resource Sharing Conference- Joel: Joel would like to have time off to go to the OCLC Conference in Virginia Beach from March 14<sup>th</sup> through March 16<sup>th</sup>, 2017. Registration fee is two hundred dollars and must be turned in by January 6<sup>th</sup>, 2017. Director checked on airfare and hotels. Airfare will run between two hundred fifty dollars and four hundred and fifty dollars and the hotels he found are the Virginia Beach Ocean Front Beach hotel at one hundred twenty nine dollars per night and the Ocean Front Beach Inn at eighty nine dollars per night. Board discussed the arrangements and decided to go with the one hundred twenty nine dollars per night as the Ocean Front Beach was closer to the conference. Director figured with the highest airfare, registration and hotel, it would cost about one thousand one hundred two dollars total. The board will have to make two motions, one to give Joel the time off and two for the total cost of the trip.
